REFUGEE & IMMIGRANT SERVICES

Illinois has been a leader nationwide in meeting the special needs of our foreign-born population. Based on the 2010 Census, 1.8 million immigrants resided in our communities, and since 1975 Illinois has resettled more than 123,644 refugees from more than 60 countries.

The Illinois Department of Human Services (IDHS) houses the Bureau of Refugee and Immigrant Services which funds, manages, and monitors contracts designed to help newly arriving refugees achieve self-sufficiency in the United States. The bureau also provides outreach and interpretation services to low-income and limited English-proficient individuals requiring supportive services. These services are available to refugees, asylees, SIV holders, parolees, low-income immigrants, and limited English-proficient individuals.

IMMIGRANT FAMILY RESOURCE PROGRAM

The Immigrant Family Resource Program is a partnership between the Illinois Department of Human Services (IDHS), the Illinois Coalition for Immigrant and Refugee Rights, and community-based and ethnic organizations across Illinois. Partners are available to provide outreach, information and referral, case management, and interpretation or translation services, especially for IDHS services.

FOOD FOR STUDENTS



With Illinois schools moving to remote learning during the COVID-19 crisis, the Pandemic Emergency Benefit Transfer (P-EBT) program was established to help Illinois families buy food for school-aged children and young adults who would receive National School Lunch Program free or reduced-priced meals when schools are in session.

If you currently receive SNAP benefits, your school-aged children are automatically eligible for P-EBT benefits and do not need to apply. Your P-EBT benefits will be automatically loaded into your Illinois LINK EBT account along with your regular SNAP benefits.

YOUTH INVESTMENT

The State is making an investment that will begin to ensure that Illinois' at-risk youth ages 16-24 have an equitable opportunity to secure employment. The Illinois Youth Investment Program aims to empower and support young people along their path toward successful, long-term employment and career development.

PAYCHECK PROTECTION PROGRAM

The Illinois Department of Human Services (IDHS) continues to strongly encourage all of its providers whose ability to provide services has been impacted, either in whole or in part, by the COVID-19 pandemic to apply for Paycheck Protection Program (PPP) funding and, if successful, to keep the federal PPP funds provided. IDHS makes this recommendation for providers to maximize federal dollars and to ensure that limited State funding is stretched as far as possible, particularly in light of increasing economic uncertainty and the impact on State revenues due to the COVID-19 pandemic.

IDHS has updated their Frequently Asked Questions page regarding PPP to address questions submitted to the email DHS.PPPQuestions@illinois.gov and to program staff. Providers are encouraged to continue submitting questions and monitoring the FAQ page found on the IDHS Coronavirus webpage.
